**Title: Authorizing Settlement of a Tax Appeal for 29 Trinity Place,
Block 1311, Lot 14.**

WHEREAS, Igor and Kathryn Soukhanov are the owners of certain real property located at 29 Trinity Place and designated as Block 1311, Lot 14 on the official tax map of the Borough of Hillsdale, Bergen County, New Jersey; and

WHEREAS, the owners has filed an appeal to the Tax Court of New Jersey for said premises for tax year 2010, under docket number 016318-2010; and

WHEREAS, the parties have engaged in settlement negotiations; and

WHEREAS, as a result of those settlement negotiations, a settlement has been reached; and

WHEREAS, the current assessment on Block 1311, Lot 14, Address: 29 Trinity Place is as follows:

WHEREAS, the following reduced assessment proposed for Block 1311, Lot 14, Address: 29 Trinity Place is as follows:

Tax Year 2010:

LAND:	\$ 331,900
IMPROVEMENTS:	<u>\$ 323,100</u>
TOTAL ASSESSMENT	\$ 655,000; and

WHEREAS, the parties further agree that to the extent permitted by law, the provisions of N.J.S.A. 54:51A-8 (Freeze Act) shall be applicable to and a final disposition of this matter as to the assessment on the property for tax years 2011 and 2012; and

WHEREAS, all refunds due Igor and Kathryn Soukhanov shall be without interest, provided that payment is made within sixty (60) days of the date of the Borough of Hillsdale's receipt of the Judgment in this action; and

WHEREAS, any refunds due as a result of this settlement shall be made payable to “Igor Soukhanova” and forwarded to Igor Soukhanova, 29 Trinity Place, Hillsdale New Jersey 07642; and

WHEREAS, the Tax Counsel and the Tax Assessor have recommended said settlement to the Mayor and Council; and

WHEREAS, the Mayor and Council is of the opinion that said settlement is in the best interests of the Borough of Hillsdale.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Hillsdale, County of Bergen, State of New Jersey, being the governing body thereof, that the settlement in this matter as set forth hereinabove be and is hereby approved and the Tax Counsel, Christopher E. Martin, Esq., is hereby authorized and directed to affect said settlement.
