**AWARD OF CONTRACT  
YEAR 2016 ROAD PROGRAM**

**WHEREAS**, sealed bids were requested through advertisement pursuant to New Jersey Local Public Contracts Law for 2016 Borough Road Program; and

**WHEREAS**, five (5) contractors returned the sealed bid documents on June 28, 2016; and

**WHEREAS**, D & L Paving Contractors, Inc., 681 Franklin Ave., Nutley, NJ 07110, was the lowest responsible bidder in the base bid amount of Two Hundred Seventy Six thousand Four Hundred Eighty Five Dollars and Ninety Seven Cents (\$276,485.97); and

**WHEREAS**, the Borough Engineer recommends that the contract be awarded to the low bidder; and

**WHEREAS**, the Borough Attorney has reviewed the bid package and found it to be in order; and

**WHEREAS**, the Borough Administrator concurs with the recommendation of the Engineer.

**WHEREAS**, this award is made subject to the NJDOT Grant Award; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Hillsdale as follows:

1. This award is made to D & L Paving Contractors, Inc, the lowest responsible bidder, in the base bid amount of \$276,485.97 with the services to be provided in accordance with the bid package and specifications prepared by the Borough Engineer's office which were used in the bidding process and are considered part of this award.
2. The Borough Attorney is hereby authorized to prepare contracts and/or other documents pursuant to the award of this contract.
3. The Mayor and Clerk are hereby authorized to execute contracts and/or documents pursuant to the award of this contract.


