(Adoption)****Title: AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 138 FEES (SOIL
MOVEMENT-CHAPTER 248)**

The following Chapter of the Code of the Borough of Hillsdale is amended as follows:

Section 1:

Chapter 138 Fees, amend Chapter 248 Soil Movement Fees to read:

Volume of Soil to be Moved*	Filing Fee	Escrow Deposit for Costs
Up to 25 Cubic Yards	\$25.00	0
Over 25 Cubic Yards	\$ 75.00	\$ 350.00
Over 50 Cubic Yards	\$ 75.00	\$ 800.00
Over 200 Cubic Yards**	\$ 75.00	\$ 1,000.00
Over 500 Cubic Yards	\$ 150.00	\$ 2,000.00
Over 1,000 Cubic Yards	\$ 300.00	\$ 3,000.00
Over 5,000 Cubic Yards	\$ 600.00	\$ 4,000.00
Over 10,000 Cubic Yards	\$1,200.00	\$ 5,000.00

* Soil Volume based on the movement of all soil within the property, i.e. import, export as well as movement of any existing soil.

** Requires Performance Guarantee >200 cubic yards, unless waived by the Borough Engineer.

Topographic plan required for all volume >50 cubic yards, unless waived by the Borough Engineer.

Re-Submission Fee \$175.00 Required when application is deemed incomplete and requires additional review by Borough Engineer.

Section 2:

All ordinances or any provisions of any ordinance inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistencies.

Section 3:

If any section, sub-section, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining provisions of this Ordinance.

Section 4: This ordinance shall take effect immediately upon final passage and publication, or otherwise as provided by law.
