**RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR
SUPPLEMENTAL SIDEWALK SNOW REMOVAL SERVICES**

WHEREAS, on October 16, 2015 the Borough of Hillsdale received bids for Supplemental Sidewalk Snow Removal Services; and,

WHEREAS, (1) sealed bids were received w from the following vendors:

Downes Tree Service Co., Inc. – Base Bid - \$140.00 per hour/per plow-truck; Alternate Bid #1- \$180.00 per hour/per plow-truck for additional trucks in excess of trucks proposed under Base Bid; and,

WHEREAS, the Borough Council is satisfied with the proposals submitted by Downes Tree Service Co., Inc. as being responsible proposals and being in conformance with the requirements promulgated pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., and which satisfies the best interests of the Borough; and,

WHEREAS, the Chief Financial Officer of the Borough of Hillsdale has certified that sufficient funds are available for this purpose.



CERTIFICATION OF AVAILABILITY OF FUND




