RESOLUTION 17058**

**AUTHORIZING THE EXTENSION OF CONTRACT FOR GRASS CUTTING ON
BOROUGH PROPERTIES**

WHEREAS, on May 5, 2015 the Borough of Hillsdale awarded the bid for Grass Cutting on Borough Properties to Pat Scanlon Landscaping for a two year period ending December 31, 2016; and,

WHEREAS, the Borough wishes to extend the contract for a one (1) year period beginning January 1, 2017 through, December 31, 2017 in accordance with N.J.S.A. 40A 11-1; as the contract service has been performed in an effective and efficient manor: and

WHEREAS, the Borough is satisfied with the proposal submitted by Pat Scanlon Landscaping as being responsible and being in conformance with the requirements promulgated pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., and which satisfies the best interests of the Borough; and,

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Hillsdale, County of Bergen, State of New Jersey that it hereby awards and authorizes the extension of the contract for Grass Cutting on Borough Property with Pat Scanlon Landscaping at the rate of \$52,514.70 per year and in accordance with the bid specifications and proposal submitted; and

BE IT FURTHER RESOLVED that the Mayor and Borough Clerk are hereby authorized and directed to execute the contract for Shade Tree and Stump Removal for the rates as set forth in the contract and in accordance with the bid specifications and proposal submitted; and,

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
