RESOLUTION AUTHORIZING THE CONSTRUCTION, LABOR AND MATERIALS TO REPLACE THE SEWER LINE AT THE HILLSDALE FIRE HOUSE THROUGH THE STATE OF NEW JERSEY COOPERATIVE PURCHASING PROGRAM N.J.S.A. 40A:11-12

WHEREAS, the Borough of Hillsdale, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program and other approved Cooperative Purchasing Programs for any State or Cooperative Purchasing contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury and/or by the approve the Cooperative Purchasing Program; and

WHEREAS, the Borough of Hillsdale is a member of the Educational Services Commission of New Jersey, New Jersey State approved Cooperative Pricing System #65MCESCCPS Purchasing Program; and

WHEREAS, the Borough wishes to replace the sewer line at the Hillsdale Fire House through the Educational Services Commission of New Jersey, New Jersey State approved Cooperative Pricing System #65MCESCCPS Purchasing Program valid 6/26/17-7/28/19; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and the Borough Clerk and Borough Administrator are hereby authorized to execute an agreement for the replacement of the sewer line at the Hillsdale Fire House with Murray Paving & Concrete 17 Park Place, Paramus, New Jersey 07652, in an amount not to exceed \$23,137.72 in accordance with the Educational Services Commission of New Jersey, New Jersey State approved Cooperative Pricing System #65MCESCCPS.
