RESOLUTION CANCELLING TAX REFUNDS/DELINQUENT AMOUNTS LESS THAN \$10.00

WHEREAS, the Mayor and Council of the Borough of Hillsdale finds and declares that N.J.S.A. 40A: 5-17.1 empowers authorized municipal employees to process the cancellation of tax refunds and/or delinquencies of less than Ten (\$10.00) Dollars, and

WHEREAS, the Mayor and Council of the Borough of Hillsdale further finds and declares that the Municipal Tax Collector is qualified to process the cancellation of tax refunds and/or delinquencies of less than Ten (\$10.00) Dollars, and

WHEREAS, the Mayor and Council of the Borough of Hillsdale further finds and declares that it is the best interest of the citizens of the Borough of Hillsdale for the Municipal Tax Collector to be authorized to process the cancellation of tax refunds and/or delinquencies of less than Ten (\$10.00) Dollars in accordance with N.J.S.A. 40A:5-17-1;

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Hillsdale, that the Municipal Tax Collector is hereby authorized to process, without any further action on the part of the Governing Body, the cancellation of any property tax refunds or delinquencies of less than Ten (\$10.00) Dollars in accordance with N.J.S.A. 40A:5-17-1; and

BE IT FURTHER RESOLVED, that a certified Copy of this Resolution be provided by the Municipal Clerk to the Tax Collector and the Chief Financial Officer.
