AWARD OF CONTRACT
VETERANS PARK IMPROVEMENT PROJECT

WHEREAS, sealed bids were requested through advertisement pursuant to New Jersey Local Public Contracts Law for the 2019 Veteran's Park Improvement Project; and

WHEREAS, three (3) contractors returned the sealed bid documents on May 30, 2019; and

WHEREAS, Balitano Contracting, Inc 298 Forest Road, Fort Lee, New Jersey 07024, was the lowest responsible bidder in the base bid amount of One Hundred Twenty-One Thousand Nine Hundred Fifty Dollars and No Cents (\$121,950.00); and

WHEREAS, the Borough Engineer recommends that the contract be awarded to the lowest responsible bidder; and

WHEREAS, the Borough Attorney has reviewed the bid package and found it to be in order; and

WHEREAS, the Borough Administrator concurs with the recommendation of the Engineer.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Hillsdale as follows:

This award is made to Balitano Contracting, Inc, the lowest responsible bidder, in the base bid amount of \$121,950.00 with the services to be provided in accordance with the bid package and specifications prepared by the Borough Engineer's office which were used in the bidding process and are considered part of this award.
2. The Borough Attorney is hereby authorized to prepare contracts and/or other documents pursuant to the award of this contract.
3. The Mayor and Clerk are hereby authorized to execute contracts and/or documents pursuant to the award of this contract.
