**AWARD OF CONTRACT
SIDEWALK IMPROVEMENTS ALONG PIERMONT AVENUE PROJECT**

WHEREAS, sealed bids were requested through advertisement pursuant to New Jersey Local Public Contracts Law for the Sidewalk Improvements Along Piermont Avenue; and

WHEREAS, twenty (20) contractors returned the sealed bid documents on May 30, 2019; and

WHEREAS, D & L Paving, 681 Franklin Avenue, Nutley, New Jersey 07110, was the lowest responsible bidder, combined with the alternate bid in the bid amount of Two Hundred Twenty-Five Thousand Eight Hundred Six Dollars and Forty-Five Cents (\$225,806.45); and

WHEREAS, the Borough Engineer recommends that the contract be awarded to the lowest responsible combined bidder (base bid & alternate bid amount); and

WHEREAS, the Borough Attorney has reviewed the bid package and found it to be in order; and

WHEREAS, the Borough Administrator concurs with the recommendation of the Engineer.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Hillsdale as follows:

1. This award is made to D & L Paving, the lowest responsible combined bidder (base bid & alternate bid amount), in the base bid amount of \$225,806.45 with the services to be provided in accordance with the bid package and specifications prepared by the Borough Engineer's office which were used in the bidding process and are considered part of this award.
2. The Borough Attorney is hereby authorized to prepare contracts and/or other documents pursuant to the award of this contract.
3. The Mayor and Clerk are hereby authorized to execute contracts and/or documents pursuant to the award of this contract.
