**CAPITAL ORDINANCE OF THE BOROUGH OF HILLSDALE, IN THE  
COUNTY OF BERGEN, NEW JERSEY AUTHORIZING VARIOUS  
PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE  
BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$1,273,712  
AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE  
RAISED FROM THE BOROUGH'S CAPITAL IMPROVEMENT FUND  
AND FROM VARIOUS GRANTS**

BE IT ORDAINED by the Borough Council of the Borough of Hillsdale, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Hillsdale, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to undertake the following public improvements and acquisitions in, by and for the Borough, including all work, materials and appurtenances necessary and suitable therefor:

(A) Administration

Undertaking of the following improvements: (i) various improvements to the Municipal Building and (ii) various improvements to Centennial Park.

Estimated Cost: \$198,312

(B) Police Department

(i) Upgrading of the downtown video camera system and (ii) acquisition of the following: (a) an SUV, (b) a commuter parking lot paystation system, (c) a mobile variable message board, (d) radio equipment, (e) service weapons and (f) traffic signs and devices.

Estimated Cost: \$169,000

(C) Fire Department

Acquisition of the following: (i) turnout gear and (ii) radio equipment.

Estimated Cost: \$93,200

(D) Department of Public Works

Acquisition of the following: (i) a front-end loader, (ii) civic decorations, (iii) a loader attachment and (iv) landscaping equipment.

Estimated Cost: \$190,000

(E) Buildings and Grounds

Replacement of the Fire House front door.

Estimated Cost: \$4,000

(F) Streets and Roads

Undertaking of the 2020 Road, Curb, Sidewalk, Culvert, Sewer and Drainage Improvement Program at various locations.

Estimated Cost: \$619,200

Section 2. The sum of \$1,273,712 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as the "improvements"). Said appropriation shall be raised from the Borough's Capital Improvement Fund and from various grants, as hereinafter provided. The sum of \$987,056 is hereby appropriated from the Borough's Capital Improvement Fund to the payment of the cost of the improvements. The aggregate amount of \$286,656 in grants is hereby appropriated to the payment of the cost of improvements, as follows: (A) \$81,656 from the County of Bergen Open Space, Recreation, Floodplain Protection, Farmland and Historic Preservation Trust Fund for the improvements to Centennial Park; and (B) \$205,000 from the State of New Jersey Department of Transportation for the 2020 Road, Curb, Sidewalk, Culvert, Sewer and Drainage Improvement Program.

Section 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
