**AWARD OF CONTRACT  
YEAR 2020 ROAD PROGRAM**

**WHEREAS**, sealed bids were requested through advertisement pursuant to New Jersey Local Public Contracts Law for the 2020 Borough Road Program; and

**WHEREAS**, eleven (11) contractors returned the sealed bid documents on July 9, 2020; and

**WHEREAS**, D & L Paving, 681 Franklin Avenue, Nutley, New Jersey 07110, was the lowest responsible bidder in the base bid amount of Five Hundred Fourteen Thousand One Hundred Fifty-Two Dollars and Eighty-Five Cents (\$514,152.85); and

**WHEREAS**, the Borough Engineer recommends that the contract be awarded to the lowest responsible bidder; and

**WHEREAS**, the Borough Attorney has reviewed the bid package and found it to be in order; and

**WHEREAS**, the Borough Administrator concurs with the recommendation of the Engineer.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Hillsdale as follows:

1. This award is made to D & L Paving, the lowest responsible bidder, in the base bid amount of \$514,152.85 with the services to be provided in accordance with the bid package and specifications prepared by the Borough Engineer's office which were used in the bidding process and are considered part of this award.
2. The Borough Attorney is hereby authorized to prepare contracts and/or other documents pursuant to the award of this contract.
3. The Mayor and Clerk are hereby authorized to execute contracts and/or documents pursuant to the award of this contract.
