

**BOROUGH OF HILLSDALE
RESOLUTION 20164**

**ACCEPTING THE BID AND AWARDING THE OPEN BID CONTRACT
FOR SUPPLEMENTAL SNOW PLOWING**

WHEREAS, on July 30, 2020, the Borough of Hillsdale received one (1) sealed bid for Supplemental Snow Plowing; and

WHEREAS, Kevin Downes Tree Service Inc., 65 Royal Avenue Hawthorne, New Jersey 07506, was the lowest and only responsible bidder with the Base Bid of \$295.00 per hour per Truck, Snow Plow and Operator, times four (4) trucks for a total cost per hour of \$1180.00; and

WHEREAS, the bid also includes Option #1 for additional plow truck(s), if needed and where directed by the Borough, at the same rate of \$295.00 per Truck, Snow Plow and Operator, times two (2) trucks for a total cost per hour of \$590.00; and

WHEREAS, the bid also includes Option #2 for additional plow truck(s) with a salter, if needed and where directed by the Borough, at the rate of \$345.00 per Truck, Snow Plow and Operator, times four (4) trucks for a total cost per hour of \$1380.00; and

WHEREAS, the base bid and the alternate bids do not have a minimum or maximum amount of hours and the Borough Administrator and the DPW Superintendent recommend that the contract for the Base Bid be awarded to Kevin Downes Tree Service Inc., the lowest and only bidder for the term of October 1, 2020 to April 30, 2021; and

WHEREAS, the Borough Attorney has reviewed the bid package and found it to be in order; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Hillsdale, in the County of Bergen, New Jersey that the bid submitted by Kevin Downes Tree Service Inc., 65 Royal Avenue Hawthorne, New Jersey 07506 for Supplemental Snow Plowing, be accepted and the Mayor and the Borough Clerk are hereby authorized to execute and award the contract for a period of October 1, 2020 to April 30, 2021, in a contract amount listed in the bid specifications.




