**AWARD OF CONTRACT
YEAR 2020 ROAD PROGRAM - AMENDING RESOLUTION 20145**

WHEREAS, sealed bids were requested through advertisement pursuant to New Jersey Local Public Contracts Law for the 2020 Borough Road Program; and

WHEREAS, eleven (11) contractors returned the sealed bid documents on July 9, 2020; and

WHEREAS, D & L Paving, 681 Franklin Avenue, Nutley, New Jersey 07110, was the lowest responsible bidder in the base bid amount of Five Hundred Fourteen Thousand One Hundred Fifty-Two Dollars and Eighty-Five Cents (\$514,152.85); and

WHEREAS, the Borough Administrator, Borough Engineer and Borough Attorney recommended that the contract be awarded to D & L Paving for the Borough Road Program in the amount of \$514,152.85 and such award was made on July 14, 2020; and

WHEREAS, the Board actually intended to include the Base Bid with the Alternate bid, and desires to amend Resolution 20145 herein.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Hillsdale as follows:

1. The award of the Base Bid to D & L Paving, in the amount of \$514,152.85 is hereby amended to include Alternate bid in the amount of \$61,375.00 respectively.
2. The total bid amount approved for the Borough Road Program to D & L Paving is \$575,527.85.
3. The Borough Attorney is hereby authorized to prepare contracts and/or other documents pursuant to the award of this contract.
4. The Mayor and Clerk are hereby authorized to execute contracts and/or documents pursuant to the award of this contract.
