**RESOLUTION AUTHORIZING THE BOROUGH ADMINISTRATOR TO APPROVE AND SIGN THE MEMORANDUM OF UNDERSTANDING BETWEEN THE BOROUGH OF HILLSDALE AND THE HILLSDALE TEAMSTERS LOCAL 125**

**WHEREAS**, the Borough of Hillsdale (the “Borough”) and Hillsdale Teamsters Local 125 (the “Union”) have entered into a Memorandum of Understanding dated October 26, 2020; and

**WHEREAS**, the Borough, given the recent resignation of an employee, wishes to hire a new employee; and

**WHEREAS**, the Borough wishes to adjust the salary of Michael Murdock as a result of same; and

**WHEREAS**, the Borough wishes to memorialize its approval of the Memorandum of Understanding, the terms of which are incorporated by reference herein; and



**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
THE BOROUGH OF HILLSDALE AND TEAMSTERS LOCAL 125**


It is hereby agreed by and between the Borough of Hillsdale ("Borough") and the Teamsters Local 125 ("Union") as follows:

1. The Borough may hire an employee at a salary of \$43,373.63 (Step 2) given the recent resignation of a DPW employee and the leaf collection season.
2. The Borough agrees to give Michael Murdock a salary adjustment of \$429.44. Such adjustment shall not affect his placement on the guide, i.e. when he advances to Step 3, he shall remain at the Step 3 salary.
3. The above shall not constitute a past practice between the parties.
