**RESOLUTION AWARDING THE CONTRACT FOR STONYBROOK SWIM
CLUB POOL OPENING/CLOSING/MAINTENANCE FOR 2021-2022
LEHMANN POOLS & SPAS**

WHEREAS, the Borough of Hillsdale promulgated bid specifications to obtain bids for the opening and closing and the maintenance of the pools at Stonybrook Swim Club for 2021-2022; and,

WHEREAS, bids were obtained in accordance with applicable law and bids for the Project were opened February 23, 2021 at Borough Hall; and,

WHEREAS, two (2) bidders responded to the Request for Bids; and,

WHEREAS, the lowest responsible bidder was Lehmann Pools & Spas with a base bid total for the 2021 season in the amount of One Hundred Thirty-Nine Thousand Seven Hundred Seventy-Four Dollars and Twenty Five Cents (\$139,774.25) for the pool opening/closing/weekly maintenance and with a base bid total for the 2022 season in the amount of One Hundred Forty-Nine Thousand Two Hundred Twenty-Four Dollars and Fifty-One Cents (\$149,224.51) for the pool opening/closing/weekly maintenance; and

WHEREAS, for both pool seasons 2021 and 2022 the hourly rate for unspecified work of \$200.00/hour and the markup on parts or materials for unspecified work at 50% were also accepted; and

WHEREAS, Lehmann Pools & Spas has met all of the bid specifications for the Project.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Hillsdale, County of Bergen, State of New Jersey that the contract for the Opening/Closing/Weekly Maintenance of Stonybrook Pools as well as the services listed above are awarded to Lehmann Pools & Spas, 644 Wyckoff Avenue, Mahwah, New Jersey 07430 and the Mayor and Borough Clerk are hereby authorized, on behalf of the Borough, to execute an Agreement with Lehmann Pools & Spas for the specified services and amounts listed above. A copy of the executed Agreement shall be on file in the office of the Borough Clerk.




