CAPITAL ORDINANCE OF THE BOROUGH OF HILLSDALE, IN THE COUNTY OF BERGEN, NEW JERSEY AUTHORIZING VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$952,250 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE BOROUGH'S CAPITAL IMPROVEMENT FUND.

BE IT ORDAINED by the Borough Council of the Borough of Hillsdale, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Hillsdale, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to undertake the following public improvements and acquisitions in, by and for the Borough, including all work, materials and appurtenances necessary and suitable therefor:

(A) Administration

(i) Acquisition of computer equipment for the use of various Borough departments, offices and agencies and (ii) undertaking of the following improvements: (a) various improvements to the Municipal Building and (b) various improvements to Beechwood Park.

Estimated Cost: \$111,250

(B) Police Department

(i) Installation of surveillance cameras at various Downtown locations and (ii) acquisition of the following: (a) SUVs, (b) automatic license plate reader equipment, (c) pedestrian crossing signs and (d) flashing stop signs.

Estimated Cost: \$188,000

(C) Department of Public Works

Acquisition of a pickup truck.

Estimated Cost: \$50,000

(D) Fire Department

Acquisition of the following: (i) turnout gear, (ii) computer equipment and (iii) self-contained breathing apparatus equipment.

Estimated Cost: \$79,000

(E) Streets and Roads

Undertaking of the 2022 Road, Curb, Sidewalk, Culvert, Sewer and Drainage Improvement Program at various locations.

Estimated Cost: \$500,000

(F) Office of Emergency Management (OEM)

Acquisition of radio equipment.

Estimated Cost: \$8,000

(G) Fire Prevention Bureau

Acquisition of radio equipment.

Estimated Cost: \$16,000

Section 2. The sum of \$952,250 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as the "improvements"). Said appropriation shall be raised from the Borough's Capital Improvement Fund, as hereinafter provided. The sum of \$952,250 is hereby appropriated from the Borough's Capital Improvement Fund to the payment of the cost of the improvements.


Section 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.


Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
