**AUTHORIZING THE EXECUTION AN AWARD OF A NON-FAIR AND OPEN  
CONTRACT FOR SPECIAL COUNSEL FOR WASTE MANAGEMENT ISSUES**

**WHEREAS**, the Borough of Hillsdale has a need to retain Special Counsel for Waste Management Issues as a Non-Fair and Open contract pursuant to the provisions of N.J.S.A.19:44A-20.4 or 20.5; and,

**WHEREAS**, the Borough Council has determined that the firm of McCusker, Anselmi, Rosen & Carvelli, P.C. located at 210 Park Avenue, Suite 301, Florham Park, New Jersey 07932 will be the most advantageous to the Borough; and

**WHEREAS**, the firm of McCusker, Anselmi, Rosen & Carvelli, P.C. has completed and submitted a "Contribution Statement by Professional Business Entity" as required by Hillsdale Borough Ordinance No. 04-14, entitled, "An Ordinance Establishing a Borough Policy for the Awarding of Public Professional Service Contracts"; and Ordinance No. 11-19 "Amending Chapter 12, Contracts, Public Professional Service and Chapter 305, Contribution Disclosure Statements"

**BE IT RESOLVED THAT**, the Mayor and Borough Clerk are authorized to execute such contract with McCusker, Anselmi, Rosen & Carvelli, P.C. for Special Counsel for Waste Management issues at a rate of \$150.00/hour plus reimbursements for reasonable expenses; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Hillsdale Borough Council hereby award a contract to the firm of McCusker, Anselmi, Rosen & Carvelli, P.C. through December 31, 2022 or until a successor is qualified or appointed.




