

**BOROUGH OF HILLSDALE
RESOLUTION 22143**

**AUTHORIZING THE EXECUTION AND AWARD OF A NON-FAIR AND
OPEN CONTRACT FOR THE REPLACEMENT OF THE AIR UNIT
LOCATED IN THE POLICE DEPARTMENT FIRING RANGE**

WHEREAS, the Borough of Hillsdale has a need to replace the air unit located in the Firing Range located in the Police Department as a Non-Fair and Open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5; and,

WHEREAS, N.J.S.A. 19:44A-20.4 et seq. commonly known as the “New Jersey Local Unit Pay to Play Law” that took effect on January 1, 2006; and

WHEREAS, the Borough has fully complied with the “non-fair and open” process set forth under N.J.S.A. 19:44A-20.1 et seq.; and

WHEREAS, the Borough Council has determined that Reiner Group, Inc. located at 11-07 River Road, PO Box 1128 Fair Lawn, NJ 07410-8128 as be the most advantageous to the Borough; and

WHEREAS, Reiner Group, Inc. has completed and submitted a “Contribution Statement by Professional Business Entity” as required by Hillsdale Borough Ordinance No. 04-14, entitled, “An Ordinance Establishing a Borough Policy for the Awarding of Public Professional Service Contracts”; and Ordinance No. 11-19 “Amending Chapter 12, Contracts, Public Professional Service and Chapter 305, Contribution Disclosure Statements”

NOW, THEREFORE, BE IT RESOLVED, that the Hillsdale Borough Council hereby authorizes the Mayor and Borough Clerk to award a contract to Reiner Group, Inc. for the replacement of the air unit located in the Police Department Firing Range in an amount not to exceed Twenty-two thousand three hundred twenty-five dollars and no cents \$22,325.00.
