RESOLUTION 22151**

**RESOLUTION SUSPENDING ARTICLE 4 SECTION 9 OF THE BY-LAWS
OF THE MAYOR AND COUNCIL OF THE BOROUGH OF HILLSDALE
FOR ORDINANCE 22-13**

WHEREAS, Article 4, Section 9 of the by-laws of the Governing Body of the Borough of Hillsdale (the “By-Laws”) provide as follows:

“No ordinance may be offered for introduction or discussion, unless it requires the Mayor and Council’s immediate consideration, if not acted upon may have a negative fiscal impact to the Borough, by any Council Member at any meeting unless it is provided to the Borough Clerk and distributed by the Borough Clerk to the Mayor and Council no later than five calendar days prior to any meeting at which it is introduced or offered for discussion,” and

WHEREAS, Ordinance Number 22-13 titled,

“ORDINANCE OF THE BOROUGH OF HILLSDALE, COUNTY OF BERGEN, NEW JERSEY APPROVING AN APPLICATION FOR A LONG-TERM TAX EXEMPTION AND AUTHORIZING THE EXECUTION OF A FINANCIAL AGREEMENT RELATED TO THE REDEVELOPMENT OF BLOCK 1210, LOTS 10-11 AND BLOCK 1211, LOTS 1-2 ON THE TAX MAPS OF THE BOROUGH”

Has been provided to the Borough Clerk and distributed to Members of the Governing Body and made public on July 11th, 2022; and

WHEREAS, the next soonest meeting of the Governing Body July 12th, 2022, and

WHEREAS, it is desirous and beneficial that Ordinance 22-13 be introduced at the earliest possible time at the aforesaid meeting, and

NOW, THEREFORE, BE IT RESOLVED by the governing body as follows:

1. The Governing Body hereby resolves to suspend Article 4, Section 9 of the By-Law with regard to Ordinance 22-13 so as to undertake a vote for introduction of said ordinance on July 12th, 2022.

2. Mark D. Madaio, Esq. and all other appropriate Borough professionals, employees, elected, and appointed officials are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Resolution.

3. This Resolution shall take effect immediately.
