**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR & OPEN
CONTRACT FOR PROFESSIONAL SERVICES TO PREPARE BID
SPECIFICATIONS FOR STONYBROOK SWIM CLUB**

WHEREAS, the Borough of Hillsdale has a need to acquire Christopher Statile Professional Engineers & Planners located at 3 Fir Court Oakland, New Jersey 07430 as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and,

WHEREAS, the Borough of Hillsdale desires Christopher Statile Professional Engineers & Planners to provide Professional Services in connection with bid specifications for the following projects:

Remove & replace the 3 large filters of the main pool - \$6,500.00
New Plaster in the Main, Diving and competition pool - \$9,500.00

WHEREAS, Christopher Statile Professional Engineers & Planners has submitted a proposal on July 8, 2022 indicating they will prepare contract bid specifications for the projects listed above at an amount not to exceed \$16,000.00; and

WHEREAS, additional professional services such as providing field visits during construction at the borough's request not expressly set forth in the basic services will be authorized by the borough prior then invoiced at various hourly rates listed in the agreement; and

WHEREAS, Christopher Statile Professional Engineers & Planners has completed and submitted a Business Entity Disclosure Certification which certifies that Christopher Statile Professional Engineers & Planners has not made any reportable contributions to a political or candidate committee in the Borough of Hillsdale in the previous one year, and that the contract will prohibit Christopher Statile Professional Engineers & Planners from making any reportable contributions through the term of the contract, and

NOW THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Hillsdale authorizes the Borough of Hillsdale to enter into a contract with Christopher Statile Professional Engineers & Planners as described herein; and,
