RESOLUTION 22164**

**RESOLUTION AUTHORIZING THE AMENDMENT OF THE EXECUTION
OF AN INTERLOCAL AGREEMENT FOR STREET SWEEPING
SERVICES BY AND BETWEEN THE BOROUGH OF HILLSDALE AND
THE BOROUGH OF PARAMUS**

WHEREAS, the Borough of Hillsdale and the Borough of Paramus adopted an Interlocal Agreement wherein the Borough of Paramus will provide street sweeping services for the Borough of Hillsdale; and,

WHEREAS, both of the parties to such Agreement are authorized by law to enter into an agreement with one another to provide jointly for any lawful service to and for the residents of the respective municipalities pursuant to the provisions of the "Interlocal Services Act" N.J.S.A. 40:8A-1 et seq.; and,

WHEREAS, the Borough of Paramus, through its Director of Public Works, has indicated that disposal fees have increased, thereby creating a need for an amendment.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Hillsdale hereby authorize the amendment to the Interlocal Agreement due to the increase in disposal fees with the Borough of Paramus for the remainder of 2022; and

BE IT FURTHER RESOLVED that the cost of disposal shall be calculated at ninety (\$90.00) dollars per ton plus three (\$3.00) per ton recycling fee for a total of ninety-three (\$93.00) dollars per ton. This rate shall also be subject to change, from time to time, to remain consistent with the cost of disposal; and

BE IT FURTHER RESOLVED that in all other respects, the Interlocal Agreement shall remain in full force and effect.
