**RESOLUTION APPROVING THE PURCHASE OF ONE (1) 2023 CHEVROLET
TAHOE PURSUIT 4WD FROM THE STATE OF NEW JERSEY COOPERATIVE
PURCHASING PROGRAM N.J.S.A. 40A:11-12a**

WHEREAS, the Borough of Hillsdale, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program and other approved Cooperative Purchasing Programs for any State or Cooperative Purchasing contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury and/or by the approve the Cooperative Purchasing Program; and

WHEREAS, the Borough of Hillsdale is a member of the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Borough will purchase one (1) 2023 Chevrolet Tahoe Pursuit 4WD Vehicle for the Police Department in the amount not to exceed \$46,221.11 through the State Cooperative Purchasing Program Contract #ESCNJ 20/21-09; and

NOW, THEREFORE, BE IT RESOLVED, that the Borough of Hillsdale approves the Purchase of one (1) 2023 Chevrolet Tahoe Pursuit 4WD Vehicle from Mall Chevrolet, 75 Haddonfield Road, Cherry Hill, NJ 08002, \$46,221.11 in accordance with the State of New Jersey Cooperative Purchasing Program, Contract #65MCECCPS - ESCNJ 20/21-09 valid September 15,2020 through September 14, 2023.


