RESOLUTION 24137**

**RESOLUTION APPROVING FUEL USEAGE BY THE BOROUGH OF
HILLSDALE ON AN EMERGENCY BASIS WITH THE BOROUGH OF PARK
RIDGE**

WHEREAS, the Borough of Hillsdale presently has an agreement with the Borough of Westwood to utilize their fuel stations; and

WHEREAS, the Borough of Park Ridge has offered the Borough of Hillsdale use of their fuel stations on an emergency basis and as a back up to their agreement with the Borough of Westwood; and

WHEREAS, the Borough of Park Ridge will charge the Borough of Hillsdale market price based upon Park Ridge's cost per gallon plus an additional administrative fee surcharge; and

WHEREAS, billing will be on a monthly basis based upon fuel consumption reports; and

WHEREAS, the Borough Administrator and Borough Attorney have reviewed this matter and recommend that the use of fuel stations by the Borough of Hillsdale to be utilized on an emergency basis be and is hereby approved; and

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Hillsdale, that the use of fuel stations by the Borough of Hillsdale on an emergency basis and as a back up to Hillsdale's agreement with the Borough of Westwood, be and is hereby approved; and

BE IT FURTHER RESOLVED, the Borough of Park Ridge will charge the Borough of Hillsdale market price based upon Park Ridge's cost per gallon plus an additional administrative fee surcharge to be billed on a monthly basis based upon fuel consumption reports; and

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized and directed to take all steps necessary to effectuate the intent of this resolution; and

BE IT FURTHER RESOLVED, that the Borough Clerk is hereby authorized and directed to forward a copy of this resolution to the Borough of Park Ridge upon its passage.


