**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR & OPEN
CONTRACT FOR SUMMER CAMP 2024 BUS TRANSPORTATION TO FIRST
STUDENT, INC.**

WHEREAS, the Borough of Hillsdale has a need for bus transportation services for Summer Camp 2024 through a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and,

WHEREAS, the proposals were promulgated by the Recreation Department; and,

WHEREAS, three (3) companies were requested to provide quotes; and

WHEREAS, three (3) companies responded and provided price quotes which was to include air conditioning service and after care service was from First Student, Inc. in the total amount not to exceed Thirty-three Thousand One Hundred Thirty Dollars and No Cents (\$33,480.00); and,

WHEREAS, First Student, Inc. has completed and submitted a Business Entity Disclosure Certification which certifies that First Student, Inc. has not made any reportable contributions to a political or candidate committee in the Borough of Hillsdale in the previous one year, and that the contract will prohibit First Student, Inc. from making any reportable contributions through the term of the contract; and

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Hillsdale, County of Bergen, State of New Jersey that the contract for air conditioned busing services for Summer Camp 2024 is hereby awarded to First Student, Inc. located at 53 Central Avenue, Rochelle Park, New Jersey 07662 and the Mayor and Borough Clerk are hereby authorized, on behalf of the Borough, to execute any and all documents with First Student, Inc. for air conditioned busing services for Summer Camp 2024 in the total amount not to exceed Thirty-Three Thousand One Hundred Thirty Dollars and No Cents (\$33,480.00).




