#### **President's Report:**

Jennifer Hausmann, our Board Secretary is leaving June 3. E. Meyerson thanked Jennifer for her four years of service to the BOH. Other board members and Lois Kohan thanked her for her work and we all wished her good luck.

<u>Health Officer and Employee Reports</u>: (copies of reports are filed). These reports include: Health Officer's activities, Public Health Nurse Reports, vital Statistics and monthly financial receipts.

- 1. Gina Behre, Health Officer, gave her report for April, 2021 COVID related:
  - Continued to participate in NJDOH daily call, weekly Bergen County Health Officer conference calls for updates and shared information related to COVID-19, Mosquitos and various public health activities.
