WHEREAS, the Board has determined that the 2023 Planning Board Annual Report satisfies the requirements of N.J.S.A. 40:55D-70.1; and

WHEREAS, the Board wishes to adopt the 2023 Planning Board Annual Report, as prepared.

NOW, THEREFORE, BE IT RESOLVED, by the Borough of Hillsdale Planning Board that the Board does hereby adopt the 2023 Planning Board Annual Report dated March 7, 2024, prepared by Christopher P. Statile, P.E., which is attached hereto as Exhibit A.
