**RESOLUTION AUTHORIZING THE SIGNING OF AN AGREEMENT
WITH COLLIERS ENGINEERING & DESIGN FOR
ENGINEERING SERVICES REGARDING TIER-A MUNICIPAL STORM
SEWER SYSTEM (MS4) REPORTING AND INSPECTIONS**

WHEREAS, the Borough desires to utilize Colliers Engineering services for implementing the conditions of the Borough’s Tier-A Municipal Storm Sewer Systems (MS4) and the New Jersey Pollutant Discharge Elimination System (NJPDES) permit located in the Borough of Hillsdale; and

WHEREAS, Colliers Engineering & Design Inc. (hereinafter, “Colliers”) has presented an Agreement to the Borough for such engineering services regarding the conditions of the Borough’s Tier-A Municipal Storm Sewer Systems (MS4) and the New Jersey Pollutant Discharge Elimination System (NJPDES) permit located in the Borough of Hillsdale; and

WHEREAS, the scope of services includes an Annual Report and Supplemental Questionnaire, a Stormwater Pollution Prevention Plan update as well as perform an Internal Compliance Audit and Outfall Inspections; and

WHEREAS, the fees related to the above referenced services are:

Annual Report & Supplemental Questionnaire	\$ 15,000.00
Outfall Inspections	<u>19,500.00</u>
	\$ 34,500.00; and

WHEREAS, the Borough desires to execute the Agreement and authorize Colliers to perform the services set forth above.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Hillsdale, County of Bergen, State of New Jersey hereby authorizes the Mayor and/or Administrator to sign the aforesaid Agreement with Colliers and all other appropriate Borough professionals are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of said document.
