**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN  
CONTRACT FOR INSTALLATION OF GYM EQUIPMENT FOR THE  
HILLSDALE POLICE DEPARTMENT**

**WHEREAS**, the Borough of Hillsdale Police Department has a need for the delivery and installation of gym equipment located at 380 Hillsdale Avenue, Hillsdale, New Jersey 07642 as a non-fair and open contract pursuant to the provisions of <N.J.S.A. 19:44A-20.4 or 20.5 as appropriate>; and,

**WHEREAS**, vendors have been solicited and three quotes were received pursuant to N.J.S.A. 40A:11-3 and it has been determined that the value of this acquisition will exceed \$17,500.00; and

**WHEREAS**, Johnson Fitness & Wellness located at 231 Executive Drive- Suite 15 Newark, DE 19702 has given the most advantageous design and quote for the delivery and installation of cardio equipment, Hybrid Functional Trainer/Rack/Plates/Bar Equipment, Free Weights, Accessory Rack and various fitness materials in an amount not to exceed Twenty-two Thousand Five Hundred Fifty-Five Dollars and Eight Cents (\$22,555.08); and,

**WHEREAS**, the above named business has completed and submitted a Business Entity Disclosure Certification which certifies the business entity has not made any reportable contributions to a political candidate in the Borough of Hillsdale in the previous year, and that the contract will prohibit the above named vendor from making any reportable contributions through the term of the contract; and

**NOW THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Hillsdale authorizes the Borough Administrator to enter into a contract with Johnson Fitness & Wellness as described herein.
