**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR & OPEN  
CONTRACT FOR PREPARING AND SUBMITTING TO THE NEW JERSEY  
DEPARTMENT OF ENVIRONMENTAL PROTECTION A SOLID WASTE  
FACILITY PERMIT MODIFICATION FOR THE HILLSDALE MUNICIPAL  
LANDFILL SITE LOCATED AT CENTENNIAL FIELD IN THE BOROUGH OF  
HILLSDALE WITH THE ENVIRONMENTAL GROUP/ENVIRONMENTAL  
INVESTIGATIONS, LLC**

**WHEREAS**, the Borough of Hillsdale desires to hire The Environmental Group/Environmental Investigations, LLC (“TEG”), with offices at 530 Chestnut Ridge Road, Woodcliff Lake, New Jersey and 805 Third Avenue, 10<sup>th</sup> Floor, New York, New York, pursuant to a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and,

**WHEREAS**, the Borough of Hillsdale desires TEG to prepare and submit a Solid Waste Facility permit modification application for the Hillsdale Municipal Landfill site located at Centennial Field based on the Colliers Engineer and Design drainage improvement design to address surface drainage issues at the Centennial Athletic Field Complex; and

**WHEREAS**, TEG will prepare and submit to the NJDEP an application for a Minor modification for a Solid Waste Facility minor permit petition and will also attend up to two meetings with the Borough and/or the NJDEP as may be required. Preparation of a new Solid Waste Facility permit, Solid Waste Facility permit or other permit application other than the Minor Solid Waste Facility modification permit is not included in this proposal. Additional fees for work beyond the scope listed above will require additional approvals. The amount for this proposal will not exceed Nine Thousand Eight Hundred Dollars and No Cents.

**WHEREAS**, TEG has completed and submit a Business Entity Disclosure Certification which certifies that TEG has not made any reportable contributions to a political or candidate committee in the Borough of Hillsdale in the previous one year, and that the contract will prohibit TEG from making any reportable contributions through the term of the contract, and

**NOW THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Hillsdale authorizes the Borough to enter into a contract with TEG as described herein; and,

**BE IT FURTHER RESOLVED**, that a certified copy of this Resolution be forwarded to the Borough Clerk, Chief Financial Officer and Borough Planning Board Chairman and Secretary,

This Resolution shall take effect immediately.




