**RESOLUTION INCREASING THE PRICE FOR SERVICES OF DLS  
CONTRACTING INC FOR THE 2024 ROAD IMPROVEMENT  
PROGRAM: RIVERSIDE COOPERATIVE PROGRAM – CHANGE  
ORDER #1**

**WHEREAS**, the Borough of Hillsdale (Borough), by Resolution 24155 dated May 7, 2024, and amended on June 11, 2024 awarded a contract to DLS Contracting, Inc. 36 Montesano Road Little Falls, NJ 07004 for the 2024 Road Improvement Program: Riverside Cooperative Program in the Borough of Hillsdale at a total contract amount not to exceed of \$336,264.78; and

**WHEREAS**, the Borough Project Engineer has proposed Change Order #1 for an increase in the amount of \$30,000.00 due to additional work required at the curb area of Piermont Avenue not foreseen in advance to complete the project; and

**WHEREAS**, the Borough Administrator is recommending the approval by the Governing Body of change Order No. 1; and

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council do hereby authorize the execution by the Administrator of Change Order No. 1 pursuant to which the contract price will be increase by \$30,000.00 from \$336,264.78 to \$366,264.78 (the “Amended Contract Price”).


