**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN  
CONTRACT FOR THE PURCHASE OF EQUIPMENT FOR THE DEPARTMENT  
OF PUBLIC WORKS**

**WHEREAS**, due to equipment that sustained damage from flooding at the Department of Public Works Building, the Borough of Hillsdale has a need to acquire a 84” 15-Drawer Triple-Bank EPIQ Series Bed Liner Power Top with LED Light Roll Cab and Power Drawer System as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and,

**WHEREAS**, the Qualified Purchasing Agent has determined and certified in writing that the value of the acquisition will exceed \$17,500; and,

**WHEREAS**, *JL Tools LLC located at 10 Morning Glory Lane Warwick, NY 10990* has submitted a proposal on July 25, 2024 indicating they will provide the 84” 15-Drawer Triple-Bank EPIQ Series Bed Liner Power Top with LED Light Roll Cab and Power Drawer System for the cost not to exceed \$22,505.00; and

**WHEREAS**, JL Tools LLC has completed and submitted a Business Entity Disclosure Certification which certifies that JL Tools LLC has not made any reportable contributions to a political or candidate committee in the Borough of Hillsdale in the previous one year, and that the contract will prohibit JL Tools LLC from making any reportable contributions through the term of the contract, and

**NOW THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Hillsdale authorizes the Borough Administrator to enter into a contract with JL Tools LLC as described herein; and,


