

**BOROUGH OF HILLSDALE
RESOLUTION 24244**

**RESOLUTION AMENDING THE CONTRACT FOR A JOINT FEASIBILITY
STUDY REGARDING AMBULANCE SERVICES
(UPDATE TO RESOLUTIONS 24220 & 24225)**

WHEREAS, on August 13, 2024, Resolution No. 24225, was adopted by the Governing Body of the Borough of Hillsdale to conduct a joint feasibility study with the Municipalities of Hillsdale, River Vale, Old Tappan, and the Township of Washington (hereinafter, collectively, the “Participants”) to assess at providing joint ambulance services to all four Municipalities; and

WHEREAS, Resolution No. 24255, was adopted awarding the aforesaid Contract, with a total cost of Seventeen Thousand, Four Hundred Dollars (\$17,400.00) to be divided equally between the Participants to MTP Group located at 161 Stanhope Road Sparta, New Jersey 07871; and

WHEREAS, it has been brought to the attention of the Participants that the Borough of Old Tappan no longer wishes to be a Participant as to this contract and study; and

WHEREAS, the Contract will now be amended to be equally divided between the remaining three Municipalities (the Boroughs of Hillsdale and River Vale and the Township of Washington) for a rate not to exceed \$5,800.00 per town to evaluate each town’s current ambulance services and to project the cost and service level of a future paid per diem service model.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Hillsdale, County of Bergen, State of New Jersey hereby authorizes Mayor Michael Sheinfeld to sign an Amendment to the Contract with MTP Group or otherwise tender payment to MTP Group in a manner that reflects three Participants, rather than four, and to take any and all other appropriate steps necessary to effectuate the purposes of said document.
