**RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF A NEW
ROTARY SM18 VEHICLE LIFT AND RELOCATE OLD VEHICLE LIFT
THROUGH THE EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY
(ESCNJ) COOPERATIVE PURCHASING PROGRAM**

WHEREAS, the Borough of Hillsdale intends to purchase (1) SM18 Rotary Vehicle Lift and relocate old vehicle lift through the Educational Services Commission of New Jersey (ESCNJ) Cooperative Pricing System Contract #65MCESCCPS Bid #ESCNJ 21/22-17 – Vehicle Lift and Accessories, of which the Borough of Hillsdale is a member; and

WHEREAS, the Borough of Hillsdale pursuant to N.J.S.A. 40A:11-12a and N.J.A. C. 5:34.7.29(C), may, by resolution and without advertising for bids, may purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State Contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury; and

WHEREAS, the Borough of Hillsdale intends to purchase (1) SM18 Rotary Vehicle Lift through Hoffman Services, Inc 55-57 East Bigelow Street Newark, NJ 07114 at the total cost of all the labor to furnish and install new left as well as provide all labor to remove, transport and reinstall existing Mohawk TP16 Lift is not to exceed \$44,347.00; and

NOW THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Hillsdale, County of Bergen, State of New Jersey hereby authorizes the purchase of (1) SM18 Rotary Vehicle Lift through the Educational Services Commission of New Jersey (ESCNJ) Cooperative Pricing System Contract #65MCESCCPS Bid #ESCNJ 21/22-17 – Vehicle Lift and Accessories.
