**RESOLUTION AUTHORIZING THE EXTENSION OF THE CONTRACT FOR  
THE STONYBROOK SWIM CLUB SPRING/SUMMER POOL LEASE  
PROGRAM**

**WHEREAS**, on February 21, 2024 a bid was awarded to Phoenix Aquatic Club USA, 139 Goebel Road New City, New York 10956 for the use of Stonybrook Swim Club for the Spring/Summer Season; and

**WHEREAS**, the Borough of Hillsdale is interested in extending their contract for the use of the Stonybrook Swim Club with Phoenix Aquatic Club USA in the amount of Thirty-Five thousand dollars (\$35,000.00) for the use of the Swim Club Lap/Competition Pool for Operation of a Summer Swim Program from April 1, 2025 through May 27, 2025 (3:00 pm to 8:00 pm) and May 28, 2025 through September 2, 2025 from 5:00 am – 8:00 am daily; and

**WHEREAS**, the Mayor and Council at its sole discretion, in accordance with NJSA 40A 11-1 et seq., the Mayor and Council may, by adoption of resolution, extend the contract for one (1) one (1) year period if they determine; that the contract service is being performed in an effective and efficient manner; and if any price change included as part of an extension shall be based upon the price of the original contract as cumulatively adjusted pursuant to any previous adjustment or extension and shall not exceed the change in the index rate for the twelve (12) months preceding the most recent quarterly calculation available at the time the contract is renewed and the terms and conditions of the contract remain substantially similar; and


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Hillsdale, County of Bergen, State of New Jersey as follows:


The extended contract for the Summer Lease of the Stonybrook Swim Club as outlined in the bid proposal is hereby awarded to Phoenix Aquatic Club USA effective April 1, 2025 through May 27, 2025 (3:00 pm to 8:00 pm) and May 28, 2025 through September 2, 2025 from 5:00 am – 8:00 am daily for the amount of \$35,000.00.

1. Any additional time required outside the specific times listed above, shall be billed at \$15.00 per hour/per lane; and
2. If the contractor wished to use the restroom facilities when Stonybrook is not open to its members, it will be charged \$20.00 per hour for the period September 3, 2025 – November 2, 2025.
3. If the contractor wishes to provide their own restroom facilities, permission from the Stonybrook Commission will be required in writing
4. The Borough Attorney is hereby authorized to prepare contracts and/or other documents pursuant to the award of this contract.
5. The Mayor and Clerk are hereby authorized to execute contracts and/or documents pursuant to the award of this contract.
