RESOLUTION 24296**

**RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN  
CONTRACT FOR THE PURCHASE OF EQUIPMENT FOR THE DEPARTMENT  
OF PUBLIC WORKS**

**WHEREAS**, due to equipment that sustained damage from flooding at the Department of Public Works Building, the Borough of Hillsdale has a need to replace three (3) Steel Insulated Doors each with a section of glass and one (1) Steel Insulated Door with a section of a pass door as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and,

**WHEREAS**, the Qualified Purchasing Agent has determined and certified in writing that the value of the acquisition will exceed \$17,500; and,

**WHEREAS**, Reiner Overhead Doors, LLC PO Box 246 Hasbrouck Heights, New Jersey 07604 has submitted a proposal on October 28, 2024 indicating they will provide the three (3) Steel Insulated Doors each with a section of glass and one (1) Steel Insulated Door with a section of a pass door for the cost not to exceed \$28,600.00; and

**WHEREAS**, Reiner Overhead Doors, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that Reiner Overhead Doors, LLC has not made any reportable contributions to a political or candidate committee in the Borough of Hillsdale in the previous one year, and that the contract will prohibit Reiner Overhead Doors, LLC from making any reportable contributions through the term of the contract, and

**NOW THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Hillsdale authorizes the Borough Administrator to enter into a contract with Reiner Overhead Doors, LLC as described herein; and,
