RESOLUTION AWARDING THE CONTRACT FOR EMERGENCY REPAIR OF TRAFFIC SIGNALS

WHEREAS, the Borough of Hillsdale promulgated bid specifications to obtain bids for the Emergency Repair of Traffic Signals in the Borough of Hillsdale; and,

WHEREAS, bids were obtained in accordance with applicable law and bids for the Project were opened November 7, 2024; and,

WHEREAS, one (1) bidder responded to the Request for Bids; and,

WHEREAS, the lowest responsible bidder was Allan Briteway Electrical Utility Contractor, Inc located at 30A Vreeland Road, Suite 220, Florham Park, NJ 07932 with a bid of Item 1 – Standard Hourly Rate – Monday- Friday \$168.00/hour per man/per hour, Item 2 Premium Hourly Rate – Overtime Monday – Saturday \$205.00 hour per man per hour and Item 3 Sundays and holidays at a cost of \$203.00 hourly per man per hour. Equipment cost for the use of a 28’-32’ reach bucket is \$40.00 per hour; and,

WHEREAS, Allan Briteway Electrical Utility contractor, Inc has met all of the bid specifications for the Project.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Hillsdale, County of Bergen, State of New Jersey that the contract for the Contract for Emergency Repair of Traffic Signals is awarded to Allan Briteway Electrical Utility Contractor, Inc and the Mayor and Borough Clerk are hereby authorized, on behalf of the Borough, to execute an Agreement with Allan Briteway Electrical Utility Contractor, Inc in the amounts listed above at an amount not to exceed \$45,000.00 without prior approval from the Governing Body.
