**REPORT OF LIAISON TO THE MAYOR AND COUNCIL:**

- Resolution was passed to refund money to Don Wager, Phoenix Aquatix.
- Community Center
  - There is a redevelopment project in town. The developer is going to give space in town for a community center and money to create a senior center at the pool.
  - The space could be built on top of the existing building or add a building somewhere closeby. It would be roughly 4,000 square feet and cost nearly 2 million dollars.
  - It would be open to all town senior citizens.
  - There is an economic development committee and they will continue to plan and the pool commission would like to be involved.
- Council was pleased with the membership from Stonybrook this year.

**TOPICS FOR DISCUSSION**

- POOL MANAGEMENT UPDATE
  - Revenue is ahead of this time last year, roughly \$800,000.
  - Swim lesson sign ups this weekend.

- Scheduling and employees, we are looking to hire more lifeguards.
- Community pass training - will be June 21 at 10am for the office staff and the gate staff.
- Mulch (18 yards) to do the entrance ways.
- Quicktech - price for a new chromebook to use for gate check-in.
- Managers meeting - nice compliments about the clean facility and kind employees.
- Uniforms are ordered and on the way in for the 2022 season.
- Swim team sign up was a decent turnout, 68 swimmers as of today. We are looking for more coaches.
- MEMBERSHIP
  - We may have to limit new membership due to the overwhelming membership enrollment.
- ENGINEER ESTIMATES FOR CAPITAL IMPROVEMENTS
  - Repairs
    - Plumber and United Water had to come and stop the meter from spewing water, they replaced it.
    - Electrician came because the pumphouse lost power.
    - Patty is still waiting for the pricing from engineers.
    - We do not have to go out to bid for the pool covers.
- SPECIAL EVENTS/REVENUE OPPORTUNITIES
  - DJ booked for 5 dates.
  - A professional mermaid program for children. .
  - A pool volleyball program for adults.
  - Biergarten scheduled for the end of July or early August potentially more if all goes well. We partnered with 5 Dimes Brewery (Westwood). Yard games, fenced in, non-members welcome for a fee, band, food, etc.
  - Facebook Poll to go out soon.
  - Triathlon - may be held at the swim club.
- OLD BUSINESS/NEW BUSINESS
  - Payroll

- Finance committee will meet separately to determine salaries and wages for management staff.
- Refund Request
  - A new member joined and is asking for a refund after May 28, 2022. Our Borough Policy clearly states no refunds and the commission has voted to not issue a refund.

- SNACK BAR
  - The commission spoke with the snack bar operator about cleanliness and overall proper sanitation for health inspection and beyond.
  - It was suggested that a cleaning service come to sanitize and then the snack bar reimburse the fee.
  - The line has been moving, but there are a lot of new employees who still require training.
  - Ceiling tiles were replaced at the beginning of the season, but during one of the rainstorms some fell out again. A repairman will be coming to fix it.
